MINUTES OF THE 5TH MEETING OF THE SYNDICATE HELD ON DECEMBER 30, 2013 IN THE MAIN COMMITTEE ROOM, ISLAMIA COLLEGE PESHAWAR

Fifth Meeting of the Syndicate, Islamia College Peshawar was held on December 30, 2013 at 10:00 hrs in the Main Committee Room, Islamia College Peshawar. The meeting was convened by Prof. Dr. M. Rasool Jan, Vice-Chancellor, Islamia College Peshawar.

The meeting started with the recitation of the Holy Quran by Prof. Dr. Nisar Muhammad, Department of Islamic Theology, Islamia College Peshawar.

The Vice-Chancellor welcomed all the participants and thanked them for sparing their precious time for attending the meeting. The Registrar formally started the meeting from the first item of the agenda.

Item # 1(i):- Confirmation of Minutes of the 3rd Meeting of Syndicate held on 17 & 19.04.2013

Decision:-

The minutes of the 3rd meeting of Syndicate held on 17 & 19.04.2013 were confirmed by the Syndicate.

Item # 1(ii):- Action taken on the Minutes of the 3rd Meeting of the Syndicate held on 17 & 19.10.2013

Decision:-

After thorough discussion on Section (ii) (25)(5) of Item 2 of the action taken, it was decided that:

In light of the Chancellor's directives regarding decisions related to six employees (i.e. Prof. Dr. Muhammad Naeem Khalid, Dr, Shazia Yaseen, Mr. Sikandar Khan, Engr Abid Kamal, Syed Farid Ahmad, & Mr. Ghayur Ahmed, Islamia College Peshawar) would be considered as if no orders against them have been issued since second meeting of the Syndicate, Islamia College Peshawar dated May 23, 2012 and all steps taken in light of that Syndicate stand withdrawn. "That the above quoted letter of registrar is against, the advertisement published in the newspapers and the Syndicate cannot change its earlier decision within a year"

Observations made by Dr. Muhammad Saleem Khan, Department of Botany, Member of Syndicate, Islamia College Peshawar.

Item 1 (ii) entitled as 'Action taken of the 3^r Meeting of the Syndicate held on 17 & 19. 10. 2013.

Under Section (ii) (25) (5) of Item 2 of the action taken, the body was disclosed about the Governor/Chancellor's directives regarding the withdrawal of cases against six (06) employees of the Islamia College Peshawar in Letter No. SO (III) 6 (II)18/GS/10/179-83 dated 21.08.2013.

I have the following observations in this connection:

- 1. The aforementioned letter in which these six cases were mentioned, was not distributed among all the members of the Syndicate and deliberately kept secret from the members of the Syndicate;
- 2. The aforementioned letter was deliberately excluded from the agenda of the Syndicate;

Minutes were recorded correctly and no member of the Syndicate demanded for provision of relevant documents.

- 4. The document or the aforementioned letter when received through another reliable source, then it was found that the Governor/Chancellor directed Higher Education Department to confirm and verify the PhD degree of the appellant (Dr. Shazia Yasin) from Higher Education Commission, Islamabad instead of directing the administration of Islamia College Peshawar.
- 5. Decision taken on Item No. 1 (ii), all the cases of the six appellants should be placed and discussed in a separate Syndicate meeting to be immediately convened, rather only to discuss new cases.
