### MINUTES OF THE 9<sup>th</sup> MEETING (EMERGENCY) OF THE SYNDICATE, ISLAMIA COLLEGE, PESHAWAR HELD ON 20<sup>th</sup> NOVEMBER, 2015

Ninth meeting (Emergency) of the Syndicate, Islamia College Peshawar was held under the chairmanship of Mr. Ajmal Khan, Vice-Chancellor, Islamia College, Peshawar on 20<sup>th</sup> November, 2015 at 10:00 hrs in the Main Committee Room. (List of the participants attached).

The meeting started with the recitation of the Holy Quran by Prof. Dr. Syed Inayat Ali Shah.

The Vice-Chancellor welcomed all the participants and thanked them for sparing their precious time for Islamia College Peshawar.
