## MINUTES OF THE 10<sup>th</sup> MEETING OF THE SYNDICATE, ISLAMIA COLLEGE, PESHAWAR HELD ON 09<sup>th</sup> FEBRUARY, 2016

The tenth meeting of the Syndicate was held under the chairmanship of Mr. Ajmal Khan, Vice-Chancellor, Islamia College, Peshawar on 09<sup>th</sup> February, 2016 at 10:00 hrs in the Main Committee Room, Islamia College Peshawar (List of the participants attached).

The meeting started with the recitation of the Holy Quran.

The Vice-Chancellor welcomed all the participants and stated that they would go precisely through the agenda and decide the cases as per rules/statutes.

After thorough discussion on the membership of Principal, Islamia College for Girls it was decided that the Principal of the constituent colleges would be elected through proper procedure mentioned in the Act and notified accordingly.

Regarding membership of Prof. Dr. Nisar Muhammad, the Vice-Chancellor apprised the members that the Higher Education Commission, on account of his plagiarism case, vide letter No. DD-QA/HEC/201/98 dated February 27, 2015 has imposed a ban on his membership of statutory body during January 27, 2015 to January 27, 2017.

The Syndicate directed the administration of the university to adopt the plagiarism policy/rules of Higher Education Commission first and then decide the case of Prof. Dr. Nisar Muhammad without any further delay.

The meeting formally started with item one of the agenda by the Registrar.

## Item No 1: Approval of minutes of the 5<sup>th</sup> Meeting of the Academic Council held on June 19, 2015.

#### Decision:-

Minutes of the 5<sup>th</sup> meeting of the Academic Council held on June 19, 2015 were approved by the Syndicate.

## Item #2:- Waiver in M.Phil./Ph.D. fee for the employees of Islamia College Peshawar

#### Decision:-

The item was withdrawn as it had already been routed through Finance &Planning Committee and would be placed before the ensuing Syndicate's meeting.

## Item # 4:- Court Case of Mr. Shakeel Iqbal for Appointment on Disable Quota Decision:

Keeping in view the court decision, the Syndicate deferred the case with the observation that the prevailing government policy for disable quota may be implemented in all future advertisements to ensure compliance of High Court directions in all subsequent recruitments. Thereafter, the case of the petitioner would be considered against the said quota as per his qualification, in consonance with law. Furthermore, a committee would be constituted by the administration to look into the High Court judgments against the University interest for recommending them for moving CPLA to the Supreme Court of Pakistan in fit cases only.



#### Item # 5:- Court case of Ms. Sarwat Zakir for Regularization of services

#### Decision:-

In compliance of Peshawar High Court judgment, the case of the petitioner was considered at par with other employees, since she has not qualified the NTS test therefore, her case for regularization could not be entertained at this stage. However, she can apply against disabled quota incorporated in future advertisements.

The Syndicate approved the relaxation of requirement of post Ph.D. experience of 8 years for appointment of Professors and 4 years for appointment of Associate Professors in the Universities/Degree awarding institutions of the country for further period of 5 years (i.e. upto June 30, 2020).

	The appointment of all chairpersons was approved w.e.f. 18/06/2015. Whereas Dr. Izhar Ullah Izhar at Serial 5 and Dr. Muhammad Saleem at Serial 6 were appointed chairman on 27/01/2016 and were Assistant Professors till the 9 <sup>th</sup> meeting of the Syndicate held on 20/11/2015. Here too, the negligence and carelessness of the registrar is obvious. The registrar should have written (and has to write now) as to when the notifications of the chairmanship of other Professors/Associate Professors were issued and when their last term expired. As a secretary-cum-registrar, he has to take every item seriously and provide all the relevant information to the members.	Dates will be corrected.
	When the chairmanship of the Department of Physics was being discussed, Dr. Inayat Ali Shah made references to some letters sent by the HEC regarding Dr. Shazia Naeem, teaching staff member in the said department. At this moment, Dr. Muhammad Saleem, a member of the Syndicate, showed and read aloud a letter sent by the HEC to the HED and the registrar on June 04, 2015. The letter is a long-awaited reply to the by-the-HEC confirmation of the eligibility of Dr. Inayat Ali for the post of Professor in the Department of Mathematics. The registrar-cum-secretary has concealed the letter from the competent authorities till date. partial and prejudiced in maintaining the affairs of the university. On demand from the members of the Syndicate, the Vice-Chancellor assured them that the case of the Dr. Inayat Ali Shah and all other such cases would be on the agenda of the coming meeting of the Syndicate.

Furthermore, Mr. Zakira, a member of the Syndicate, demanded of the other members that the headship of the administrative departments should also be on rotation exactly on the pattern of the teaching departments. Being a justified one, the demand was decided positively.

The item was not on the agenda. It was mere suggestion of a member.

#### Agenda Item # 06

### Approval of the Meeting of the Recommendations of the 14<sup>th</sup> Selection Board of Islamia College Peshawar

The decision regarding the post of Assistant Professor in the Department of Botany has been wrongly recorded. The chairman concerned (who is also a member of the Syndicate) apprised the honorable members that the post was advertised without taking the workload of the department concerned into consideration of an outsider would overstaff the department concerned and overburden the exchequer of the university which is already short of funds. The secretary-cum-registrar tried to hoodwink the members of the Syndicate by saying that the department concerned and the TSA had demanded the said post but couldn't come up with proofs. Consequently, the Syndicate constituted a three-member committee comprising the Vice-Chancellor, the Chairman Department of Botany and Mr. Khalid Khan, Additional Secretary, Higher Education Department.

It was never mentioned that the registrar would be even its secretary, let alone member of the said committee. Owing to this bias and partiality, the secretary-cumregistrar miss-quoted the decision. Blindfolded by his partiality and prejudice towards the department concerned and in utter disregard for the rules, the registrar recorded his person as secretary-cum-member of the said committee. Para 3-4a of the KP Public Sector Universities Act (Amended in 2015) says that the secretary-cumregistrar can't act as the member of any committee constituted by the Syndicate.

Feeling himself at a loss in this case, the secretary-cumregistrar told that in case of no workload all the already advertised posts be abolished. To this, I Awal Said, a member of the Syndicate replied that the secretary was, by law, only to take notes and had no right to comment. I further added that in the government colleges, teachers get promoted to higher scales after a certain number of years. On the contrary, in the universities posts are advertised for the appointment of the eligible teachers

The minutes were recorded correctly.

The word abolished will be replaced by cancelled.

No observation regarding cancelation of the post advertised was made by the department at any stage of processing. Moreover, the Chairman sitting in the Selection Board didnobject the same.

Since the Registrar holds the records therefore, the presence of the Registrar is a must to help the committee and provide any relevant record which may be needed.

Since this is a University and not a Government college, therefore, it has to act in accordance with its Act/statutes whereby, all teaching positions have to be advertised and selection made on the basis of merit only.

against the higher scales. The universities can't confirm its teachers in the same scales for good even if the departments don't have workload. Moreover, the universities have to find teachers to become chairmen and deans in order to run the affairs.

In brief, the Syndicate authorized the said committee to decide justification of the said post. It didn't authorize the committee to abolish the other posts. The members knew well that creating and abolishing posts is the domain of the F&PC.

In the wake of all this, Prof. Dr. Masoom yasinzai and Mr. Khalid Khan regretted that the secretary-cum-Registrar had not brought all the relevant data regarding the recommendations of the Selection Board despite the fact that he had been asked guite a few times before this. The Registrar assured that he would be careful in future.

All record was available and was being provided on demand.

#### Agenda Item # 11 and 12

#### Grant of Premature Increment, Mobile and Land Line Allowance

As regard item 11 and 12, the members censured the secretary-cum-registrar for putting them on the agenda of the Syndicate before their being recommended by the F&PC. The Syndicate criticized the willful negligence of the secretary-cum-registrar regarding financial matters which are to be recommended by the F&PC before approval by the Syndicate.

Observations made by Prof. Dr. Syed Inayat Ali Shah and Dr. Gohar Zaman, Members of the Syndicate, Islamia College Peshawar

Kindly refer to the minutes of the Syndicate meeting held on 09.02.2016. We, the members of Syndicate request incorporation of the following observations in the minutes:

- During the discussion regarding the legal status of Dr. Naeem Khalid, a question was raised that why the serious allegations and findings against him are not brought on the agenda of syndicate despite explicit directives from HED and written appeal from teaching community. The Vice-Chancellor first showed lack of knowledge about any such thing but after some arguments and factual revelations, he promised that the same will be put on the agenda of the next meeting of the Syndicate.
- 2. The condition attached to serial No. 7 in item No. 6 (i.e. subject to clarification of his case by the HEC) in case of Dr. Saleem-Ur-Rehman, Associate Professor, Islamic Theology was objected to be unfair and arbitrary on the grounds (i) that he had applied for the post in 2013 before the publication of questionable research paper bearing his name as co-author and the subsequent penalty recommendation by HEC in Feb. 2015, (2) that as the only eligible candidate he was issued call letters for appearing before the Selection Board but was deprived the opportunity on one reason or the other, (3) that the objectionable paper was formally withdrawn, a written apology was submitted for the mistake to the University administration and the Registrar Islamia College Peshawar Ref.679/Estt:23/02/2014 had requested HEC to file the case (4) that the Peshawar High Court in its judgment (Hussain Faroog Vs ICP) dated dismissing petition of Dr. 28/04/2015 while Hussain Faroog has specifically validated the eligibility of respondent No. 5 i.e., Dr. Saleem-Ur-Rehman and (5) that the penalty is totally void under section 11 -C-1 of the plagiarism policy of

## Observations made by Dr. Izhar Ahmad, Member of the Syndicate, Islamia College Peshawar

The following observations on the tenth meeting of the Syndicate are submitted to your office to be considered for the needful.

#### 1. Membership of Prof. Dr. Nisar Muhammad

Dr. Muhammad Saleem Khan, member Syndicate, pointed out by showing the notification about the membership of Dr. Nisar Muhammad. According to the notification, the membership of Prof. Dr. Nisar Muhammad expi9red on 29/11/2015 as he had been elected for the remaining period. He cannot sit in the meeting. Dr. Muhammad Saleem Khan further said that why Prof. Dr. Nisar Muhammad had been called for the tenth meeting of the Syndicate while the fact is that the latter is not member of the Syndicate. The Registrar is playing a negative role in the case. The Registrar commented that the notification about the membership was not issued under his signature and that it had mistakenly been issued by his predecessor. On the contrary, the letter clearly shows his signature as mentioned by Dr. M. Saleem Khan.

The Registrar has notified it for the remaining period vide No. 1574/Estt. dated 16.12.2013.

He also argued on the basis of the workload that the department does not need the appointment of any new faculty from outside as this would be a financial burden on the University. Prof. Dr. Massom Yaseenzai, member Syndicate, showed dissatisfaction on the lack of strategic plan in the University and lack of coordination of the Registrar with the teaching departments. He said how we can accept a situation where the Chairman concerned clearly says that I do not need any further staff from outside and the University is pushing him for an additional staff- this would result in the overstaffing in the university while on the other hand the university is comprehensively crying about the financial crunch in the university. After thorough and lengthy discussion, the Syndicate constituted a three-member committee comprising:

- Mr. Ajmal Khan, Vice-Chancellor, Islamia College Peshawar
- Dr. Mohammad Saleem Khan, Chairman, Department of Botany
- 3. Dr. Khalid Khan, Member Syndicate

No other person was nominated for this committee in any capacity. Moreover, the Registrar could not be a member of such committee (Khyber Pakhtunkhwa University Act-2012 Amended in 2015).

The mandate given to the committee is to investigate the demand of the post and the existing workload of the department. This committee was never constituted for the other advertised and under process posts. Moreover, the committee of the Syndicate cannot create or/and abolish a post until it follows a prescribed procedure.

The minutes were recorded correctly.

The word abolished will be replaced by cancelled.

No observation regarding cancelation of the post advertised was made by the department at any stage of processing. Moreover, the Chairman sitting in the Selection Board didn't object the same.

Since the Registrar holds the records therefore, the presence of the Registrar is a must to help the committee and provide any relevant record which may be needed.

#### Observations made by Dr. Muhammad Saleem, Member of the Syndicate, Islamia College Peshawar

Regarding the membership of Prof. Dr. Nisar Muhammad, the imposition of ban on his membership by HEC was not the only reason. It was also brought before the Syndicate that his membership expired on 29/11/2015. As he had been elected for the remaining period. There is guilty of concealing the facts and calling him for meeting.

When the chairmanship of the Department of Physics was being discussed, the secretary/registrar did not record the decision of the Syndicate regarding the confirmation of eligibility by the HEC for the post of professor of Prof. Dr. Syed Inayat Ali Shah (as pointed out by Dr. Muhammad Saleem). The HEC sent a letter (No. 1-3/AD-1/HEC/HED(ICP)2015/313 dated June 04,2015) to the HED and sent its copy to the Registrar ICP on June 04,2015. The Registrar has concealed the letter and its contents from the Vice-Chancellor and the Syndicate. The Vice-Chancellor assured the members that the case of Prof. Dr. Syed Inayat Ali Shah would be thoroughly discussed in the next meeting of the Syndicate.

About all financial cases i.e. item 2, 11 and 12, the Syndicate members remarked that it is the inefficiency of the administration that these cases were brought to the Syndicate before being recommended by the Finance & Planning Committee

The decision was recorded not properly because the Chairman of the Department of Urdu and Botany at serial No. 5 and 6 were Assistant Professor on 18/01/2016, so the period of each Chairman should be properly mentioned against his/her name in these cases and in the others. Might we not deem this, negligence and inefficiency of the secretary-cum-Registrar?.

Biased and irrelevant statement:

Prof. Dr. Nisar Muhammad was not invited to the 10<sup>th</sup> meeting of the Syndicate.

The Registrar has notified it for the remaining period vide No. 1574/Estt. dated 16.12.2013.

He was referring to the notification issued by then Registrar vide notification No. 447/Regr. Dated 28.03.2013.

Imaginative statement: Prof. Dr. Syed Inayat Ali Shah's case was brought into the knowledge of the Vice-Chancellor well in time.

The case will be placed before the Syndicate meeting with the approval of the competent authority.

The observations are biased. Minutes were recorded correctly.

### Observations made by Mr. Zakria Qasmi, Member of the Syndicate, Islamia College Peshawar

Kindly refer to the minutes of the syndicate meeting held on 09/02/2016 the following observations may please be incorporated in the minutes:

The condition attached to serial No. 07 in item No. 06 (i.e., subject to clarification of his case by the HEC) in case of Dr. Saleem-Ur-Rehaman Associate Professor Islamic Theology was objected to be unfair and arbitrary on the grounds (i) that he had applied for the post in 2013 before the publication of questionable research paper bearing his name as co-author and the subsequent penalty recommendation by HEC in Feb. 2015. (2) that as the only eligible candidate he was issued call letters for appearing before the Selection Board but was deprived the opportunity on one reason or the other, (3) that the objectionable paper was formally withdrawn, a written apology was submitted for the mistake to the University administration and the Registrar ICP 676/Estt:23/05/2014 had requested HEC to file the case (4) that the Peshawar High Court in its judgment (Hussain Faroog Vs Islamia College Peshawar)dated 28/05/2016 while dismiss ion the petition of Dr. Hussain Faroog has specifically validated the eligibility of respondent No. 5 i.e. Dr. Saleem-Ur-Rehman and (5) that the penalty is totally void under section 11-C-1 of the plagiarism Policy of the HEC as the co-author has neither listed the paper in question in his resume nor taken any benefit out of it.

The case was discussed as mentioned in the observation but the decision is recorded correctly.

#### Comments of the Chairman of the Syndicate/Vice-Chancellor:

The allegations/ charges made against the administration regarding concealment of facts, impartiality, negativity etc. seem unjustified and do not suit a teacher and particularly a member of Syndicate, which should be avaided in future.
