The meeting started with recitation of the Holy Quran by the Chair. He welcomed all the members of Syndicate, specially the external members, for sparing their precious time for this important meeting. The Vice Chancellor informed the house about the steps taken to expedite various matters that were pending since long. In particular, he pointed out that the meetings of various bodies like Academic Council and Advance Studies & Research Board are now held frequently so that issues do not linger on for longer. The Chair likewise pointed out that he has initiated a number of austerity measures, with the cooperation of faculty and staff, to address the main issue of financial crises faced by the University. He added that the instant Syndicate meeting has a lengthy agenda due to the fact that regular meeting of the Syndicate could not be held for the last few months. However, he expressed his determination to hold frequent meetings of the Syndicate in future so that issues faced by the University could be resolved through collective wisdom in a timely manner. The Chair expressed his resolve to decide all matters on the agenda strictly as per rules of the University. He finally asked the Secretary to present the agenda.

Item No. 2(c): 15<sup>TH</sup> MEETING OF THE ACADEMIC COUNCIL, ISLAMIA COLLEGE PESHAWAR WAS HELD ON AUGUST 23, 2021.

Decision:

The forum discussed these minutes at length and acceded to. However, it was decided that the 03 Credit Hours will be added to the workload of the faculty members till June 2022 because the elected faculty members did not agree to the decision made by the Academic Council regarding additional 03 Credit Hours to be added to the existing teaching workload of the faculty. They insisted to link approval of the said additional workload with current financial crisis of the ICP and to grant approval of the same till June 2022, in the first instance; and if the financial crises couldn't be overcome during this period, then the said increase in Credit Hours may be reprocessed through Academic Council/Syndicate.

Item No. 3: CONSTITUTION OF THE SELECTION BOARD

Item No. 3 (a): NOMINATION OF ONE EMINENT RESEARCHER AS MEMBER OF SELECTION BOARD TO BE NOMINATED BY THE SYNDICATE

Decision:

As per Clause-vi of Sub-Section-1 of Section-5 of the Islamia College Peshawar Constitution, Functions and Powers of the Authorities of the University Statutes-2016, the Syndicate considered the nomination of Eminent Researchers and authorized the Vice Chancellor to appoint Prof. Dr. Muhammad Iqbal Chaudhary as Member of the Selection Board.

Item No. 4: REPORTS OF THE COMMITTEES

REPORT OF THE COMMITTEE CONSTITUTED BY THE 25TH SYNDICATE Item No. 4.1: HELD ON 11.04.2021 NOTIFIED VIDE NO. 818/ESTT: DATED 27.04.2021

Decision:

The Syndicate considered the report of the committee constituted by the Syndicate in its 25th meeting held on 11.04.2021. The Convener of the committee apprised the Syndicate that there is no provision for regularization of Contract Employees without following the prescribed procedure. He also shed light on the recommendations of the committee made after tiresome work. After threadbare discussion, the house decided as under:

- a. In light of the decision conveyed to ICP by the Honorable Peshawar High Court Peshawar, the payment will continue for further three months w.e.f. date of the Syndicate, i.e. up to 10.12.2021 (as Terminal Period) or completion of the recruitment process, whichever is earlier, as per their respective status as on 03.02.2021.
- b. Need assessment shall be carried out by the University within two weeks from the date of approval of the minutes of the Syndicate, before carrying out the process for filling the vacant positions on regular basis.
- c. The initial advertisement floated for the contract appointments of petitioners (non-faculty employees) will be considered valid for initiating recruitment process on regular basis, subject to the needs of the University and following all the prescribed procedures. The Registrar recorded his note of dissent, owing to changes in Statutes, criteria, selection process. He also stated that regular positions can only be filled through proper advertisements under the relevant Statutes.
- d. For those employees (non-faculty) hired without advertisement, vacant positions on regular basis will be advertised subject to needs of the University and following all the prescribed procedures.
- e. Contract teachers (Petitioners) will be assigned workload. After 10.12.2021, they will be paid for the classes taken on visiting basis.
- f. For those faculty-members who have already applied against the advertised vacant posts for regular appointments, the process will be expedited.
- g. For faculty-members who have not applied for the already advertised regular posts, or the respective positions have not been advertised previously, regular vacant posts will be advertised subject to needs of the University and following all the prescribed procedures.

- h. Those faculty-members who have completed Three years contractual service may be dealt as per Section 11(5) (e) of KP Universities Act 2012 (Amended 2016) and they will be paid for the verifiable services they have rendered as faculty during the period they had no valid contractual service.
- i. Those faculty-members who have not completed Three years and have been granted Contract under Section 11(5) (e) of KP Universities Act 2012 (Amended 2016) shall be paid for the verifiable services they have rendered as faculty during the period they had no valid contractual service.
- j. In case of TGT, the posts will be re-advertised. However, those who have already applied, will not be required to apply afresh. The marks they obtained in the earlier conducted test will remain intact.
- k. In case of children of deceased employees, policy of the Government of Khyber Pakhtunkhwa will be placed before the ensuing meeting of the Syndicate for adoption.
- Item No. 4.2: CONSIDERATION OF THE MINUTES OF THE MEETINGS OF THE ANOMALY COMMITTEE NOTIFIED VIDE NO. 1760/ACAD: DATED 19.12.2017 AND NO. 2793/ESTT: DATED 14.09.2017
  - a. MINUTES OF MEETING OF THE ANOMALY COMMITTEE NOTIFIED VIDE 1760/ACAD DATED: 19.12.2017 HELD ON 20.01.2021 (Restructuring of Faculties)
- Decision: The Syndicate considered the recommendations of the Anomaly Committee held on 20.01.2021 and unanimously decided to refer the matter to the Academic Council, Islamia College Peshawar to propose to the Syndicate scheme for reconstitution of the Faculties as envisaged under Section 25(2)(c) read with Section-28(1)(i) and Section-28(2) of the Khyber Pakhtunkhwa Universities Act, 2012 (Amendment 2016).
  - b. MINUTES OF MEETINGS OF THE ANOMALY COMMITTEE NOTIFIED VIDE NO.1760/ACAD DATED: 19.12.2017 HELD ON 07.05.2018 AND 15.05.2018 (Age limit)
- Discussion: The Syndicate thoroughly discussed the recommendations of the Anomaly Committee in accordance with Section-4(1) & (2) of the Islamia College Peshawar Title, Commencement, Application and Definitions of Islamia College Peshawar Statutes, 2016. The Syndicate was of the view that section-3(1)(g) read with the Faculty Appointment Criteria (Annexure F) of the Islamia College Peshawar Teachers, Appointment and Scales of Pay Statutes, 2016,

is silent about the upper age limit for appointment of teaching faculty. Therefore, the same has never been reflected in the advertisements for appointments made from time to time. The age limit seems to be a typo mistake for the reason that the initial appointment in the teaching cadre initiates from BPS-18, whereas, Section-6(2) of the Islamia College Peshawar Teachers, Appointment and Scales of Pay Statutes, 2016, interalia, prescribes the upper age limit for BPS-1 to BPS-5 which is an absolutely irrelevant provision. The same section also provides for the age limit from BPS-6 to BPS-18 which is once again totally irrational.

### Decision:

Based on the above position, the Syndicate under Section-4(2) of the "Islamia College Peshawar Title, Commencement, Application and Definitions of Islamia College Peshawar Statutes, 2016", agreed with the recommendations/interpretation of the Anomaly Committee to the extent that the age limit mentioned in the increment clause has been incorporated wrongly and therefore the same is ineffective.

Moreover, as per Section-4(1) of the Islamia College Peshawar Title, Commencement, Application and Definitions of Islamia College Peshawar Statutes, 2016, the Syndicate decided that the upper age limit for initial appointment as Lecturer (BPS-18) shall be 50 years on the analogy of University of Engineering & Technology Peshawar.

In view of the above, the Syndicate unanimously approved the following recommendations deferred by the Syndicate in its 24<sup>th</sup> Meeting held on 30.12.2020 with immediate effect:

TTS CASES

Discussion:

The house was apprised that the Syndicate in its 24th meeting dated 30.12.2020 constituted a committee with regard to the TTS cases. The Committee held its 02 meetings on 20.01.2021 and 09.02.2021. The lists of publications of all candidates were sent to the Directorate of Quality Assurance, the University of Agriculture Peshawar as well as Quality Enhancement Cell, Islamia College Peshawar for evaluation of publications as per Statutes of the University. The publications evaluation reports received therefrom were perused by the Committee and found as meeting the criteria required for promotion under Islamia College Peshawar Tenure Track System Statutes, 2016 besides the recommendations of DTRCs, experience, TRPs etc. strictly in light of Statutes.

Decisions:

The Syndicate approved the recommendations of the committee w.e.f. date of 24<sup>th</sup> meeting of the Syndicate i.e. 30.12.2020 and directed to process the cases for endorsement from HEC in order to avoid financial loss to the University, along with placing the same on the agenda of the Senate, Islamia College Peshawar for the grant of Tenure.

The Syndicate also decided to refer Section 2.3.4(h) of ICP Tenure Track System Statutes 2016 to the Anomaly Committee for deletion as per prescribed procedure, as recommended by the above-mentioned committee.

Item No.5 (c):

CONSIDERATION OF THE APPOINTMENT CASE OF DR. HAMAYUN KHAN AS PROFESSOR, DEPARTMENT OF CHEMISTRY, ISLAMIA COLLEGE PESHAWAR

Discussion:

The house was apprised that on the recommendation of the Selection Board in its 25<sup>th</sup> meeting dated 27 to 29 July 2018, the Syndicate in its 16<sup>th</sup> meeting held on 31.08.2018 approved the appointment of Dr. Hamayun Khan as Professor, Department of Chemistry (BPS-21) subject to clarification from the HEC regarding resignation of TTS faculty desirous of applying for BPS posts as contained in Annexure-G of the Islamia College Peshawar Tenure Track System Statutes, 2016. Moreover, the matter was also placed before the 24<sup>th</sup> meeting of the Syndicate held on 30.12.2020, which upheld the decision of the 16<sup>th</sup> meeting of the Syndicate dated. 31.08.2018. Consequently, an email was sent to Director (Quality Assurance Division), Higher Education Commission, Islamabad for guidance in the matter. The HEC responded that "If a faculty"

member on tenure track system chooses to apply against an advertised higher TTS/BPS position (before completing his/her track/probation period) in the same or any other university, he/she would be required to resign from the university service before applying for the higher position. Such a resignation shall be accepted only if the faculty member is finally selected for the advertised higher position. To further clarify the matter and avoid any legal complications, the case was next referred to the legal counsel of the University who opined that "the requirement of resignation in the first instance is for the incumbent in Tenure Track while the appointment of Dr. Hamayun Khan as Tenured Associate Professor was endorsed by HEC w.e.f 15.12.2016 thus he had already completed his probation period before applying for the post of Professor BPS-21".

While discussing this case, it was pointed out that this issue was deferred in the previous Syndicate as the Registrar's office was waiting to get advice of the HEC, and the University administration was mandated to get the same and report to the Syndicate relevant correspondence from the HEC, then after the clear directives of the HEC, resorting to legal opinion was unauthorized, redundant and illogical.

As four of the elected faculty members of the Syndicate differed over the position explained above. Therefore, it was suggested by Prof. Dr. Abdul Salam (elected faculty member) that the matter may be decided through voting.

Decision:

Majority of the members especially the external members including the nominee of the Chief Justice, Peshawar High Court Peshawar, Nominee of HEC, Nominee of HED, Nominee of Finance Department, Government of Khyber Pakhtunkhwa and Dr. Khalid Khan (elected faculty member) voted in favour. However, four of the elected faculty members and Nominee of Establishment Department voted against. The Chairman, Syndicate also voted in favour while the Registrar and Treasurer, ICP did not participate in the voting. Thus, the Syndicate decided by majority to appoint Dr. Hamayun Khan as Professor (BPS-21) in the Department of Chemistry with immediate effect.

REPORT OF THE COMMITTEES

Item No. 6.1:

CONSIDERATION OF THE CASE OF DR. MADIHA ASGHAR, ASSISTANT PROFESSOR (TTS), DEPARTMENT OF PSYCHOLOGY, ICP

Discussion:

Dr. Madiha Asghar was appointed as Assistant Professor (TTS) dated 11.03.2010. As per TTS Statutes, she was required to be tenured after completion of six years. But even after a lapse of 11 years and 6 months, she has failed to even submit her dossier for tenure-ship, despite numerous letters and reminders served upon her from time to time, leave alone to be tenured. As per the Higher Education Commission Letter No. CON.QA/HEC/TTS-137/322 dated 04.12.2017 that "On completion of six years' probation period as Assistant Professor, University must finalize his/her case for appointment/tenure as Associate Professor for which the evaluation process must be initiated soon after completion of five and half years. After six years, if the decision is not taken, all the financial cost will be borne by the University itself for Assistant Professor on tenure track". At this point, Prof Dr. Abdul Salam (elected member) clarified that HEC must be followed in true letter and spirit with regard to TTS and categorization of Journals.

The Syndicate thoroughly discussed the matter. Dr. Zahoor Jan (elected faculty member) was of the opinion that Dr. Madiha Asghar has suffered

from skin cancer and she remained in a state of coma for a period of 4 months in the year 2018. Therefore, the case may be considered sympathetically. Dr. Saleem ur Rahman (elected faculty member) suggested that the forenamed may be appointed on BPS to resolve the issue on humanitarian grounds. Dr. Khalid Khan (elected faculty member) had a sympathetic opinion for her, too. However, the rest of the forum opposed these suggestions.

The house was informed that whenever the University administration tried to ask her for submission of the dossier and to fulfill the mandatory requirements on her part, she never bothered to comply with the same, rather she resorted to defaming the University by various means. The Syndicate was of the opinion that this case is an example of laxity on the part of the administration to take timely action. The Syndicate deliberated on the question that the forenamed be terminated forthwith and action be taken against those responsible for keeping her in service for such a long period of time even after her failure to perform. This opinion was endorsed by other members too who were of the opinion that the instant case is typical example of insubordination, misconduct and inefficiency on part of Dr. Madiha Asghar.

On the question of what action to take next in the instant case, Ms. Justice (Retd) Irshad Qaiser opined that Dr. Madiha Asghar has been served sufficient notices/letters and, being on TTS, there is no need to waste time and resources of the University by issuing her show cause for further action, especially when the terminal contract to be given to TTS faculty on the 7th year, as envisaged under Section 2.5(a) of the ICP TTS Statutes, has also been lapsed. In support of her opinion, Ms. Justice (Retd) Irshad Qaiser heavily relied on Section 2.1(a) of the Islamia College Peshawar TTS statutes which provides that "the services of a faculty member having tenure shall be terminated only for adequate cause..." This opinion was seconded by the remaining members of the Syndicate.

Decision:

Therefore, the Syndicate decided the following:

- Dr. Madiha Asghar is terminated with immediate effect under intimation to Higher Education Commission Islamabad.
- (2) The following Committee is constituted to fix responsibility on those responsible in the instant case:

# Item No. 6.3: CONSIDERATION OF THE REPORT OF THE PROBE COMMITTEE NOTIFIED VIDE NO. 648/ESTT: DATED 18.03.2021 REGARDING THE CASE OF MR. ISRAR IQBAL AWAN, LECTURER, DEPARTMENT OF COMPUTER SCIENCE

Discussion: The Registrar explained to the house the severity of the instant case by stating that the appointment of Mr. Israr Iqbal Awan was set aside by the Honorable Peshawar High Court Peshawar in its judgment in W.P No. 129-P/2016 dated 22.11.2016 and the case was remanded to the Selection Board/Syndicate for fresh process as follows:

"In view of the above discussion it is held that the selection of the respondent no. 6 as Lecturer in Computer Science (BPS-18) in Islamia College, Peshawar is based on favoritism and nepotism and as such the same is set aside, however, the matter is remanded to the Selection Board and Syndicate for re-evaluating experience marks etc. on the available record in a transparent, legal and lawful order of the petitioner and respondent no 6, but within a period of one month, positively, as the selection is the domain of departmental authorities".

However, contrary to the directives of the Peshawar High Court Peshawar, the case was not processed by the then University administration and the forenamed was not only retained in the service of the University but also his application was processed for confirmation of his services and subsequently the same were confirmed and notified. The Registrar further added that the CPLA filed by the forenamed has also been dismissed. Thus, the forenamed has been drawing salary for the last 56 months without being in service of the University.

However, Nominee of HED and Prof. Dr. Abdul Salam (elected faculty member) raised objection on status of the Committee. They were of the opinion that if a case is to be brought to the Syndicate, the Committee has to be constituted by the Syndicate itself and not by the Vice Chancellor. Furthermore, one of the persons involved in the instant case VIZ Dr Inayat Ali Shah (Meritorious Professor BPS-22) is higher in grade as compared to that who conducted inquiry in the instant case VIZ Prof Dr M. Salim Khan (BPS-21). Prof. Dr. Abdul Salam said that the committee was ill-constituted by the Ex-Vice-Chancellor and the same may be reconstituted to probe the matter afresh.

On the other hand, Engr. Syed Imtiaz Hussain Gilani expressed his astonishment at such state of affairs in the University. They stated that trying to keep such cases under the carpet by any technical basis is tantamount to protecting those who are responsible in this case and further added that asking for fresh committees in such cases is wastage of time. Therefore, responsibility must be fixed instantly. Likewise, the Nominee of Establishment Department, Mr. M. Taufeeq categorically stated that similarity/seniority in rank of the Committee members is not mandatory in the instant case. He gave examples of an ASI in Police Department/other agencies who investigates cases, or the GIT officials conducting inquiries are below the rank of faculty/officers/Vice-Chancellor in the University. In a similar vein, Ms. Justice (Retd) Irshad Qaiser was of the opinion that Mr. Israr Iqbal Awan is not an employee of the University after the judgment of the High Court and that the judgment be implemented in letter and spirit because the forenamed is drawing salaries illegally.

Decision:

After thoroughly deliberating the matter, the Syndicate decided that the report submitted by the Committee be considered as a fact-finding report only. Further, the instant report may be placed afresh before ensuing meeting of the Syndicate for necessary action and decision. It was also decided that:

### Item No. 6.4: CONSIDERATION OF THE CASE OF MR. MUHAMMAD SHAHZAD, SUB-ENGINEER (ELECTRICAL), ICP

Discussion:

The Syndicate discussed the case of Mr. Muhammad Shahzad in detail. The Registrar apprised the house that the instant appointment pertained to BPS 1-16 and this is why the Committee was constituted by the then Vice Chancellor. However, Prof. Dr. Abdul Salam stated that the current Committee is ill-constituted. The Nominee of the HED expressed that a committee consisting of members who are below the rank of those who are held responsible in the findings of the Committee is not justified. He likewise added that the

Committee comprises of internal members only while external members should have been included in the Committee. He also inquired if those declared responsible in the report have been given opportunity of hearing. The Registrar clarified that all concerned have been given opportunity of hearing. Dr. Zahoor Jan, Dr. Saleem ur Rahman and Mr. Salah ud Din apprised the forum that Mr. Muhammad Shahzad has filed CPLA in the Supreme Court of Pakistan and therefore the case may be kept pending till decision of the apex court. However, Nominee of the HED clarified that proceedings can be initiated even in case of pendency of the case in the apex court if there is no restraining order.

The Nominee of the Finance Department as well as the Nominee of the Establishment Department favored the Committee report and clarified that the Committee is only fact finding in nature. This is why, they argued, that the instant report should be sufficient ground for initiating proceedings against the responsible tiers. They likewise clarified that equivalency of rank/grade is not a requirement in the case of fact-finding committees. Dr. Khalid Khan also endorsed this stance and stated that the recommendations made in the current report be considered by the House.

Decision:

After threadbare discussion, the Syndicate declared the report of the Probe Committee as "fact-finding report". Discussion:

The Registrar apprised the house about the background of the case and stated that a complaint was received from Ms. Amina Ashfaq which was referred to the Inquiry Committee notified by the Islamia College Peshawar vide Notification No. 3714/Acad: dated 26.10.2020 under sub-section-2 of Section-3 of the Protection against Harassment of Women at the Workplace Act-2020. The Committee submitted its detailed report and not only absolved Dr. Amir Ullah from the charges levied against him in the complaint, but also recommended action against the complainant as follows:

- 1. The complainant and her witnesses namely M. Sana Ali and Ms. Seyala may be proceeded under the Islamia College Students Conduct & Discipline Regulations 2009. If this cannot be materialized due to any legal complications, in that case, 2<sup>nd</sup> recommendation may be followed.
- 2. The complainant and her witnesses namely Ms. Sana Ali and Ms. Seyala Qasim may be proceeded under Section 5(3) of the Protection against Harassment of Women at the Workplace Act, 2010 read with Section 12 of the Higher Education Commission's Policy on Protection against Sexual Harassment in Higher Education Institutions.

Similarly, the Governor Inspection Team also conducted inquiry in the instant case and absolved Dr. Amir Ullah of the charges. However, the complainant had simultaneously filed her complaint in the office of the Ombudsperson Khyber Pakhtunkhwa who decided the case against Dr. Amir Ullah and

ordered his removal from institution. Dr. Amir Ullah filed an appeal against the Judgment made by the Ombudsperson, to the Governor Khyber Pakhtunkhwa under Section 9 of the Protection against Harassment of Women at the Workplace Act 2010, which is not yet decided.

The Registrar informed the house that a separate public interest petition No. 5177-P/2020 has been filed in the Honorable Peshawar High Court Peshawar. Although the petition is not against Dr. Amir Ullah and he is not even a party in the same, the Honorable Court has directed that the judgment of the Ombudsperson be placed before the Syndicate for decision. The house was further apprised that a letter No. SO(II)6(11)6GS/10/210-11, dated 02.09.2021 has been received from the office of the Honorable Governor, Khyber Pakhtunkhwa wherein the Vice Chancellor has been requested that the judgment of the Provincial Ombudsperson may be excluded from the agenda of the Syndicate.

Afterwards, the Syndicate discussed the case thoroughly. Since the appeal of Dr. Amir Ullah is pending disposal before the Appellate Authority (Honorable Governor Khyber Pakhtunkhwa), the Syndicate decided to defer the case till final decision of the case by the Honorable Governor, who acts like a court of appeal in this case and therefore decision from his office should be awaited.

**Decision:** Therefore, the Syndicate unanimously decided to defer the case.
