ELIGIBILITY OF STUDENTS FOR AWARD OF THE SCHOLARSHIPS

- a. All students of FA/F.Sc, MA/MSc and MS/M.Phil programs are eligible having a minimum CGPA of 2.5 in previous exam in case of semester system or at least 60% marks obtained in annual system for MA/M.Sc and MS/M. Phil. Moreover, All FA/F.Sc students who have got admission in open merit are eligible for the said scholarships.
- b. Maximum level of income limit for the eligibility of the student parent's/ guardians is 40,000 per month and is subject to revision of the committee from time to time.
- c. On job MA/M.Sc and MS/Mphil students are not be eligible for the award of the scholarships.
- d. Students already availed another scholarship or students with no fee are not eligible for the scholarships.
- e. The scholarships will be granted keeping in view the income, neediness and academics of students.
- f. In case of falsification of documents or information provided by the students, the committee reserved the right to withdraw the scholarship and along with penalty as decided by the committee on case to case basis.
